Candidate Information Consistency

Candidates should be open, honest and consistent throughout the hiring process:

Candidates must be particularly thorough, consistent and accurate when providing their personal history throughout the NYPD Police Officer application process. The Psychologists, as well as other NYPD personnel who review the collected data will view a Candidate's lack of thoroughness, consistency and accuracy when describing their personal history in a negative light, believing those Candidates who give inconsistent responses to life history questions are more likely to become disciplinary problems later on. In addition, omitting items on life history questionnaires and/or any discrepancies found between an applicant's self-reported background/life history information and the information submitted in support of other applications can also be viewed negatively and may be adversely considered when final suitability judgments are being made.
